This has reference to your application I.D. 2. An Expert Team conducted onsite evaluation of the program from **29th to 31st August, 2025**. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Government MCA College, Maninagar (East), K K Shashtri Education Campus, Khokhra Road, Maninagar (East), Ahmedabad Gujarat 380008 as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.** If such an instance comes to NBA's notice, this will be viewed seriously.
